In addition to his executive experience, David was previously Senior Independent Director of both Premier Foods plc and Ten Entertainment Group plc. David has a degree in Chemistry from University College, Oxford.

I'm delighted that David will be taking over from me, building on the senior Domino's experience in the company that Nils Gornall and Andrew Rennie brought to the Board with their appointment earlier this year. Combined with David's experience working in Poland, I couldn't imagine a better placed successor.

DP Poland has been transformed and matured significantly during my tenure and is now ideally placed to prosper, with a clear strategy and first-class leadership team."
